




Executive Summary:

The external union vulnerability climate in Stockton is HIGH.

1)	High /	Union assets relate to the number of union members that can be pushed into your area, the percentage union members relative to the total area population, and union financial resources. Unions currently have approximately 16427 members in your area and union density is approximately 5%. Union assets are estimated at \$458.84 per member. These data suggest that unions in your area have enough resources availible to sustain an organizing drive.
2)	High /	Organizing activity relates to the frequency of petitions of unions in your area, particularly unions of interest. Unions filed 74 petitions in your area over the last 10 years. An average of 4.3 petitions per year were filed by unions of interest. Of those industry petitions 70% resulted in actual elections. These numbers reflect a somewhat high likelihood that a union will select your company as an organizing target even without specific information that they will be successful in a union election.
3)	Extremely High	Contracts in effect refer to the frequency of contract expirations within 10 miles of this location. Each time a contract expires there is a possibility of a labor dispute close to this location. We measure the number of contract expirations in the last 10 years (this may include multiple expirations of the same contract). There were 196 contract expirations in your area in the last 10 years. Of this number there are 76 contract expirations with unions of interest to DBI. This data relates to union density and suggests that the probability of a labor dispute close to your location is significantly high.
4)	Low / Moderate	Strike frequency assesses the number of strikes in the last 10 years in your area. In the last 10 years 6 strike(s) occurred in your area. Of these, 4 strikes are of concern (i.e. strikes by unions of concern) to your specific organization. This data suggests that if a union petition is successful within your organization the union involved is less likely to cause major work stoppages in your organization.
5)	High / Moderate	The legal climate where your organization is located assesses right to work status (operating in a right to work state is generally a more favorable legal environment) and the number of unfair labor practices filed against unions in the area over the last 10 years (the more charges filed the more hostile the legal environment). Your organization is not located in a 'Right to Work' state. There have been 5 unfair labor practice (ULP) actions filed in the area in the last 10 years. Together these factors suggest a moderately unfavorable legal environment.

Petition Activity HIGH/MODERATE VULNERABILITY


Petition Activity by Year

If the moving average line is moving up significantly that indicates increased external vulnerability.

Petition Activity by Union




The key issue to consider here is how many unions of interest are the top ten most active unions in the area. The more unions of intere on this list, the more external vulnerability you have.

Election Activity by Union



Election Win Rates




■ Company Wins **■** Union Wins

Strike Activity by Year




Strike Activity by Union
